- We are installing a 10,000 gallon diesel fuel tank to a property zoned M-2. The footprint of the pad is 32' x 16' (as noted on building permit application). This is the only new work at the property. A full survey and site development plan seem excessive. The existing building was constructed in the 1970's and will remain as is.
- This project will have minimal disturbance and impact to the said property and surrounding properties.
- The location of the tank is behind the building at least 50', away from roadways, and a minimum of 100' from property lines.
- There is no existing SDP and this work is extremely minimal. There will be no alteration to the road, water, sewer, access, parking, circulation, drainage, landscaping, structures or other site features.

NOTES:

- the edge of the pad will be 50 feet from the building
- the edge of the pad will be 110' from property fence.
Property line is approx. 30' past the fence toward Guilford Road
- the edge of the pad will be 142' from the fence inside the property line shared by the cemetery
