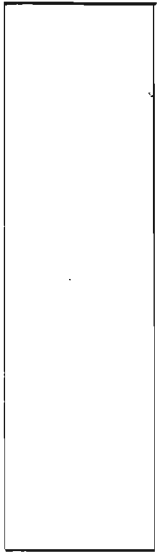

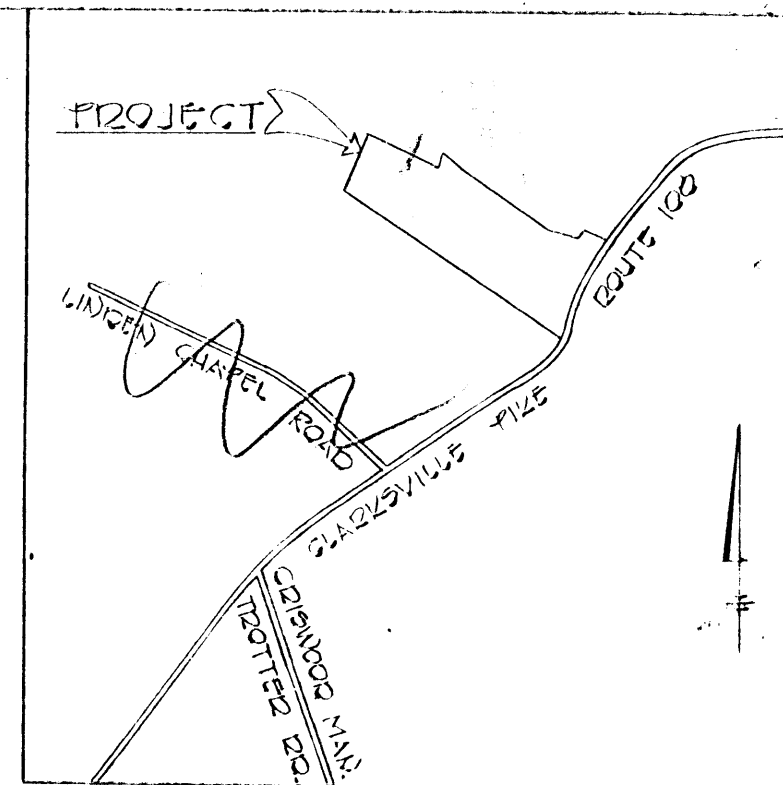

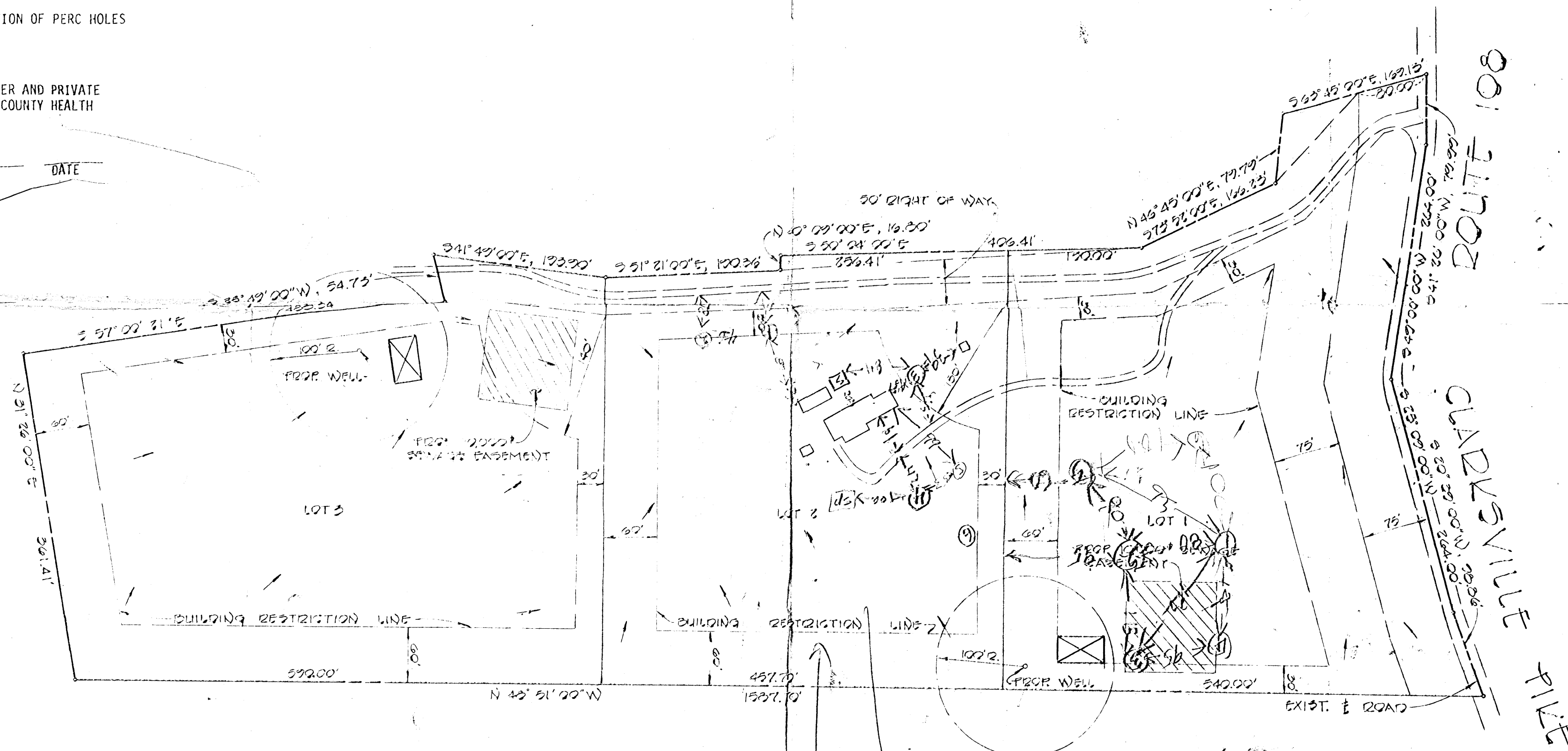
VICINITY MAP

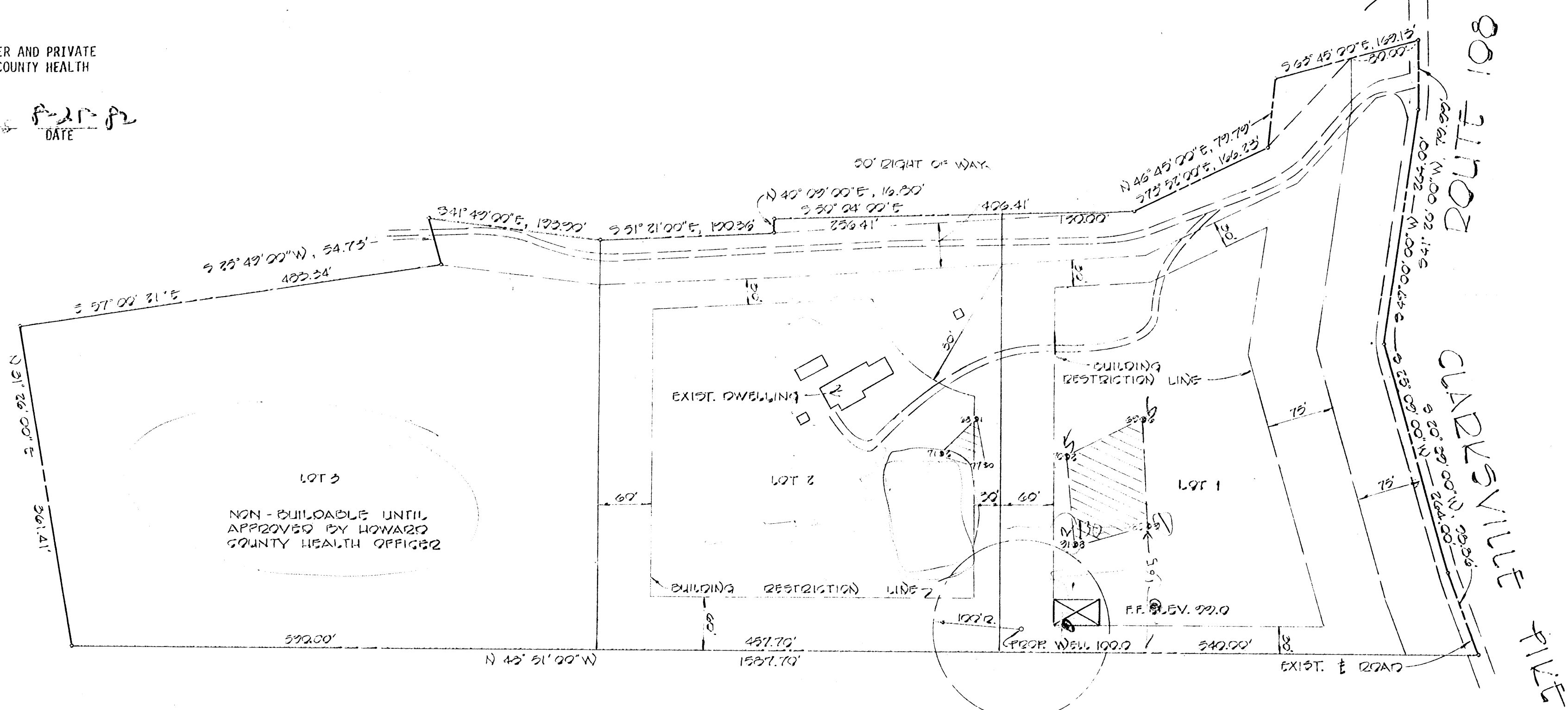
