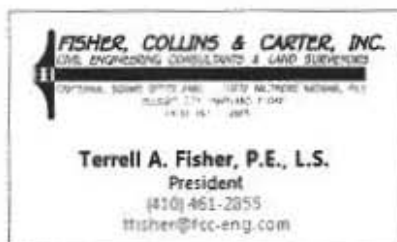
Good morning Jeff and Robert:
