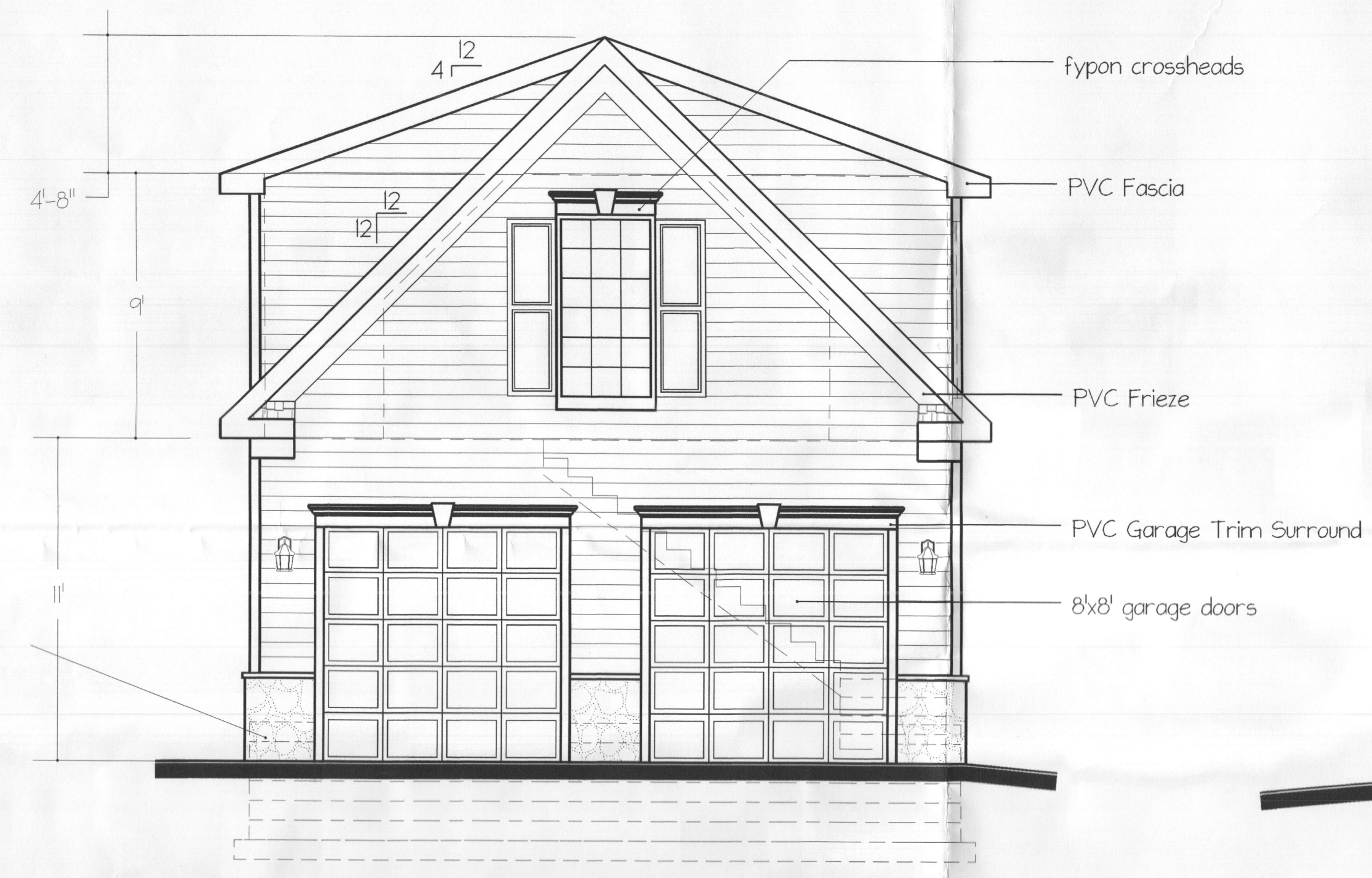

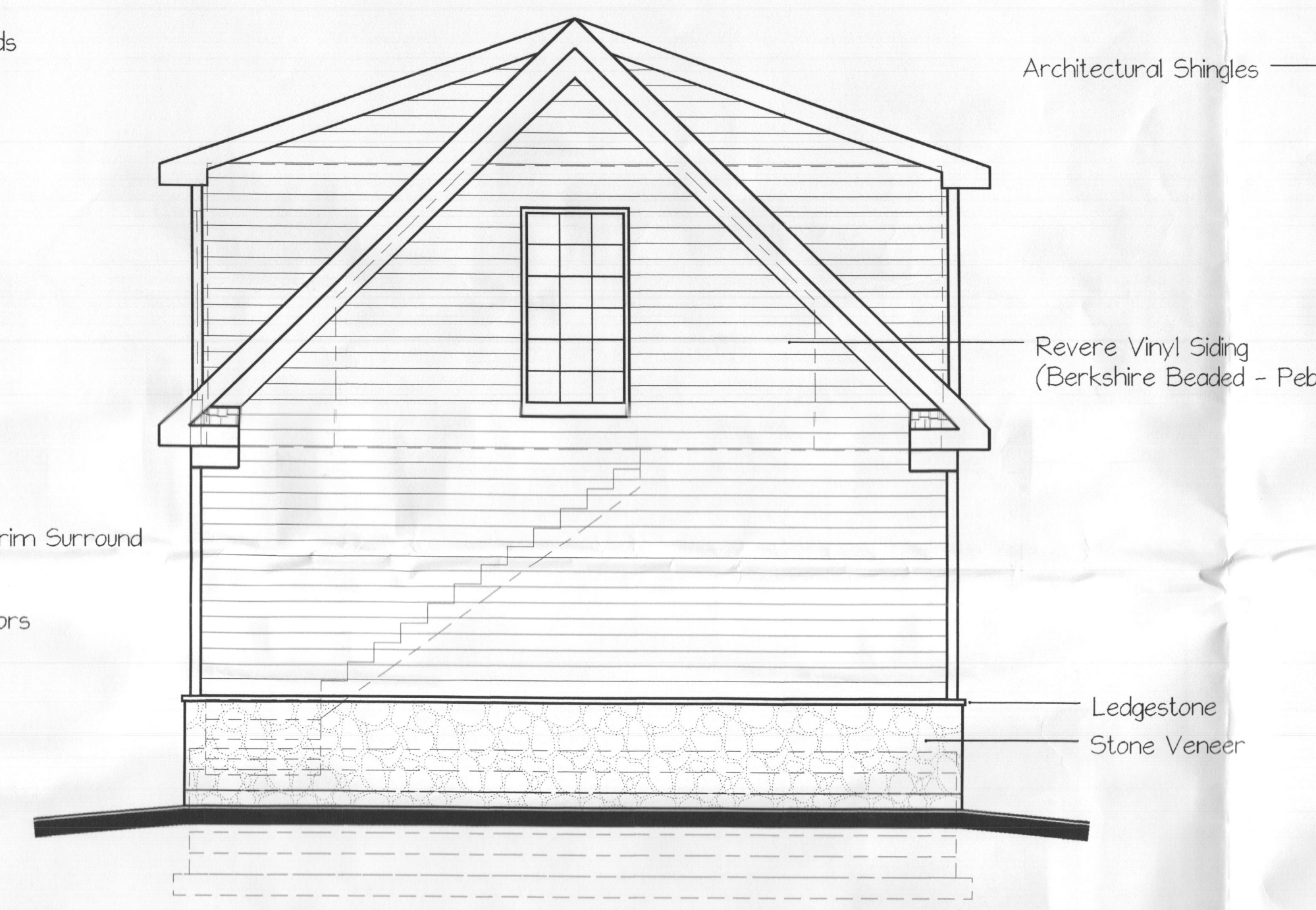

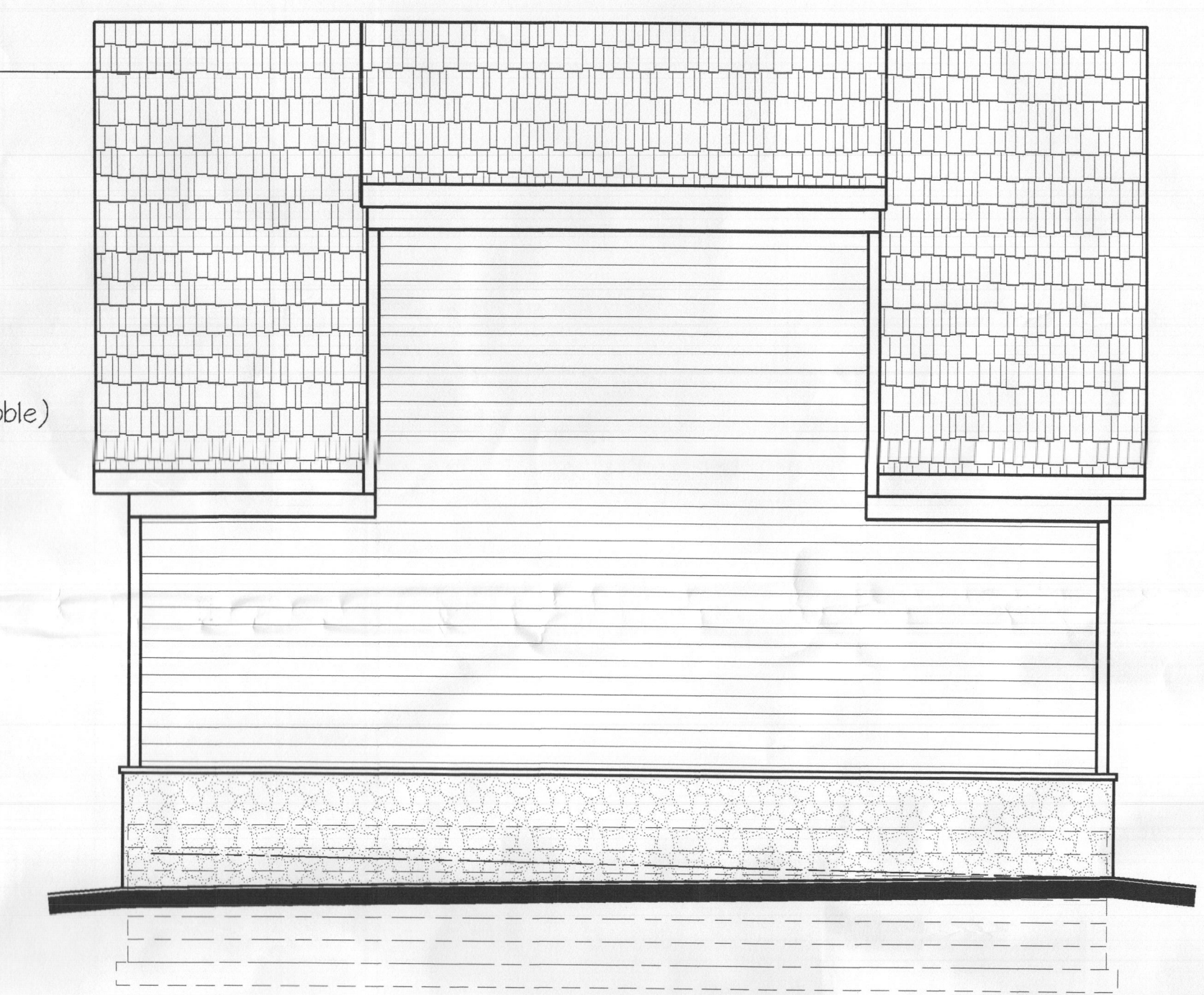

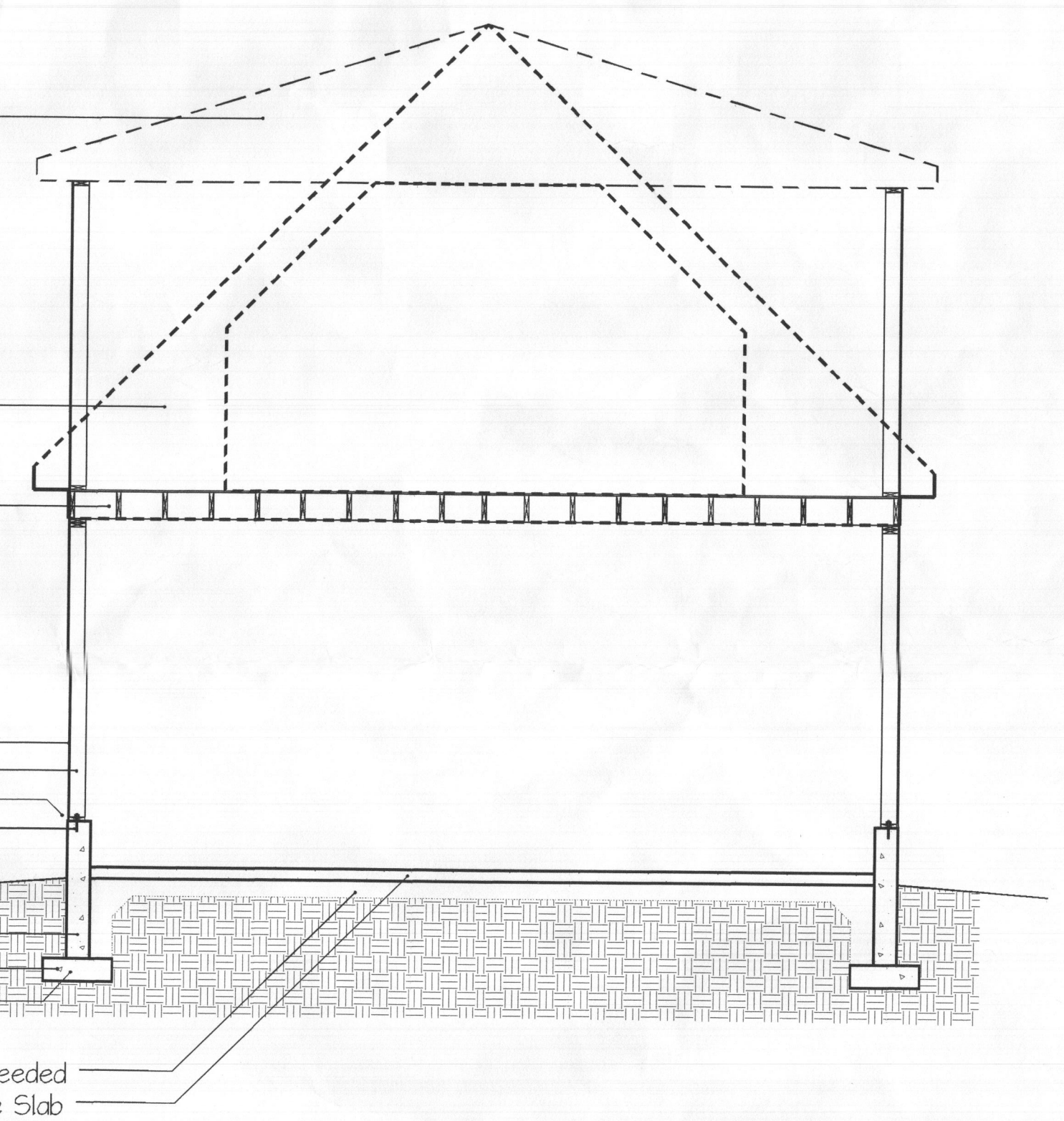

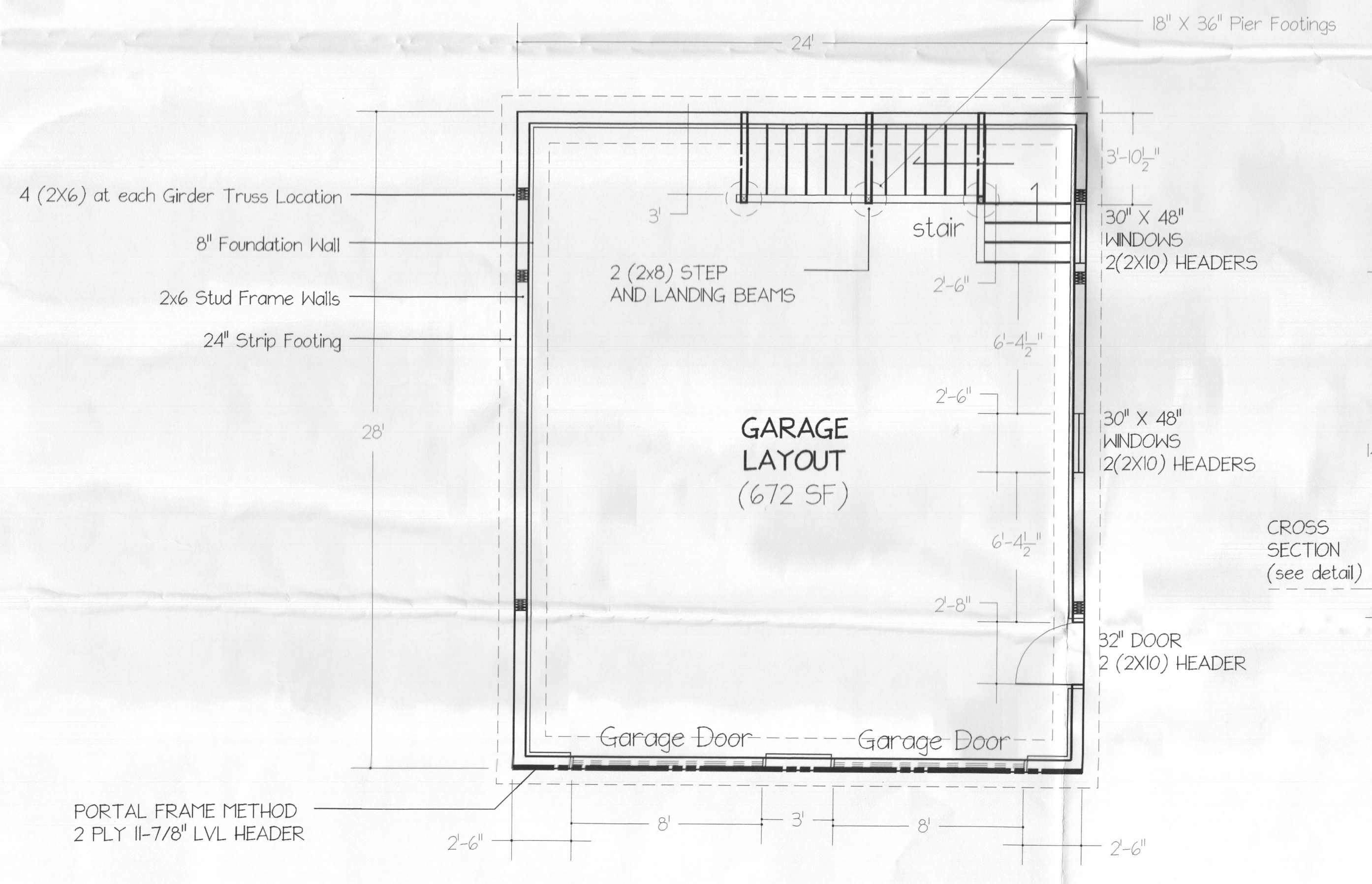

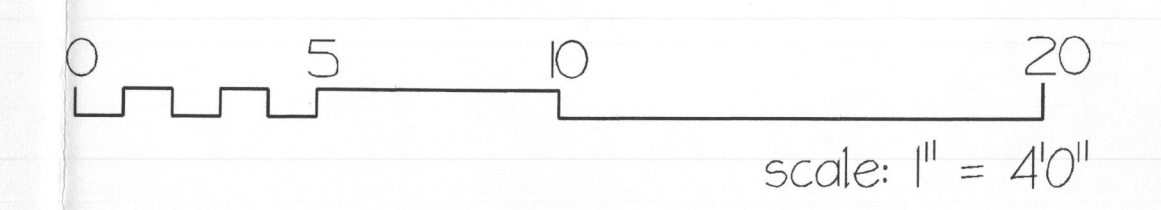
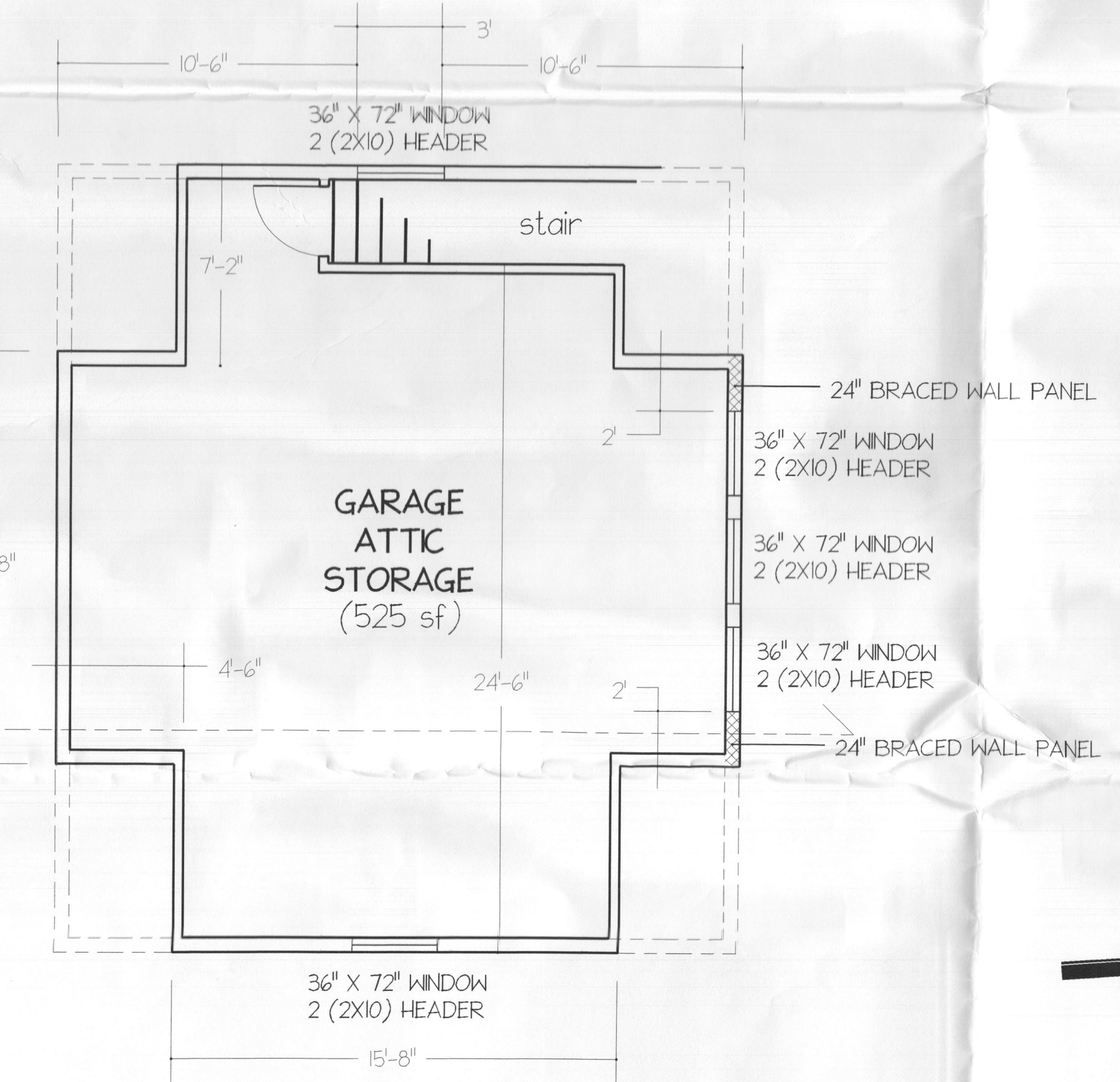
2x10 Floor Joists framed into Girder Truss
