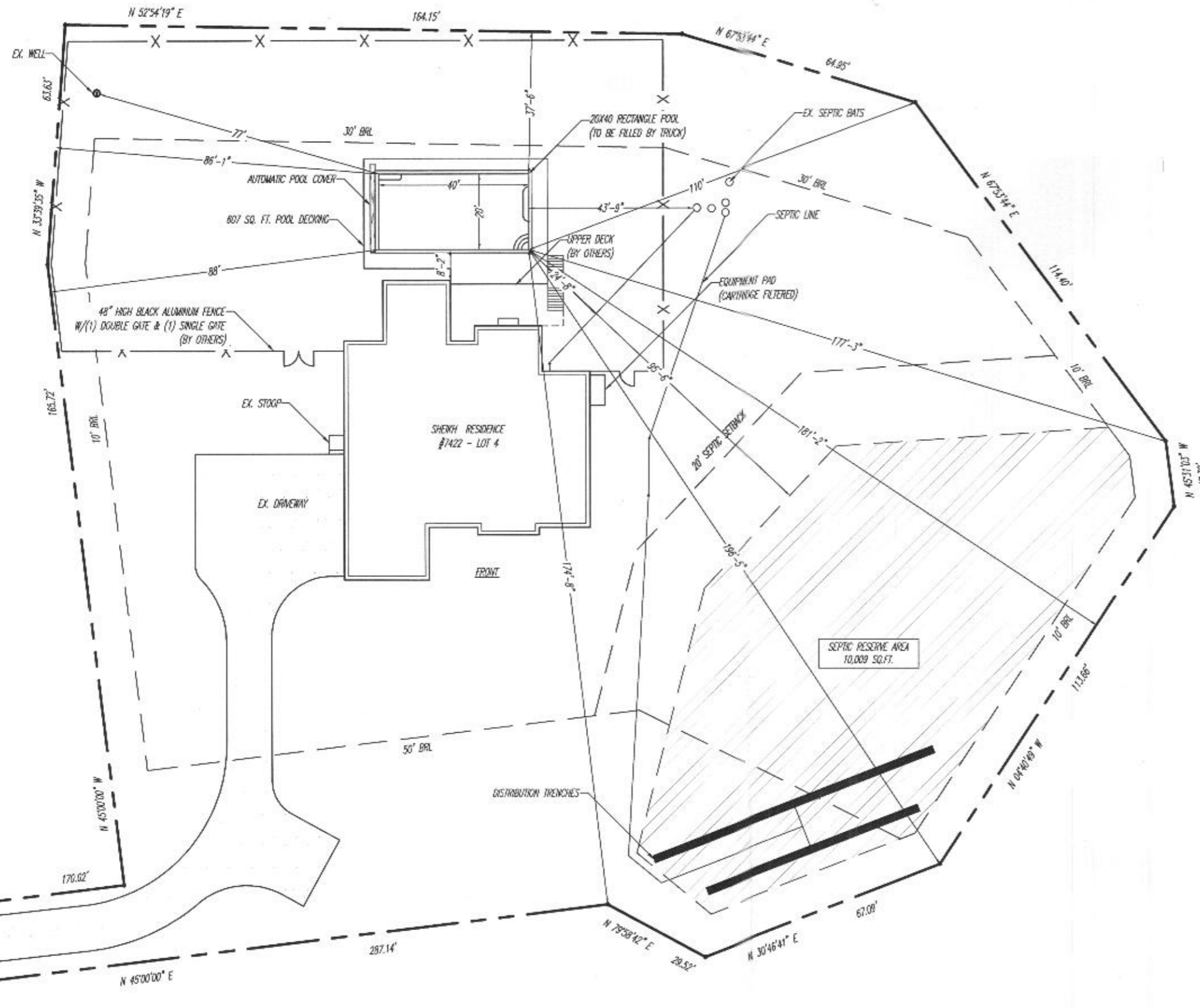

VICINITY MAP

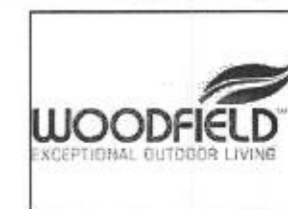
